



Pledges for the 30% protected areas target

Methodology for assessing the 30% / 10% protected area targets

Note that the 30%/10% targets are not MS level targets but to be achieved in the marine biogeographical region. Thus there will be some burden sharing involved between MS. Moreover, MS with more than one regional sea may decide to share their contribution between those basins


Analysis will consider


- Total current and future expected area covered by protected areas

* Should be considered as preliminary estimates only, as the MS are still updating their pledges






Information submitted in the pledges - OECMs

- Denmark proposes 24 new designations, either additional protection for existing sites, extension of current sites or new protected areas.
- Six are new Natura 2000 sites, while the remaining 18 are designated under national legislation.
- It is reported that the Natura 2000 sites will have management plans,
 with a timeline of introducing measures by 2027.
- While all sites have a responsible management body identified, only the Natura 2000 sites are regarded as being sufficiently resourced
