



Mainland France : 366 MPAs covering 44,8% of marine waters


• 4,1% of marine HPA

Strict and high protection

Highly protected areas are "geographical areas in which the pressures generated by human activities that might compromise the conservation of the ecological features are eliminated or significantly reduced, in the long term, through the implementation of protection through property or an adapted regulation, associated with an effective control of these activities"








Where are we going ?

Targets per Sea Basin - 2027





Target for mainland – 2030






